- A. Approve and authorize Mayor to sign contract with Independent Water Service, Inc. for daily operational activities of City's water system: Mayor Hall briefly explained that, since the the city no longer has a potable water certified employee, the city is currently out of compliance with the State Department of Health, and contracting with this company would bring us to a compliant status. Mayor Hall concluded that the person coming out to monitor our water system resides in Yakima, WA. A motion was made by Councilman Ashbrooks to authorize the Mayor to sign the contract with Independent Water Service, Inc. Motion seconded by Councilman Riddle. Motion carried unanimously.
- B. Review, Accept, and Approve Huibregtse, Louman Associates, Inc. Bid/Contractor recommendation for the downtown Sidewalk Project; Granite

Construction @ \$155,667.00, for the Base Bid Schedule: Mayor Hall briefly explained that the bid came in lower, so Elm Street would not be included in project. A motion was made by Councilman Ashbrooks. Motion was seconded by Councilman Buchanan. Motion carried unanimously.
